1. Overview

5. Terms & Conditions

- 5.1 This invitation for bids is open to all national bidders, service providers in Pakistan.
- 5.2 All prices should be quoted in Pak Rupees and inclusive of all Government Taxes & Levies.
- 5.3 A bank draft equal to 2% of the total estimated cost mentioned in Tender notice/Invitation to e-Bid should accompany the Bidding Document as **Bid Security** drawn in favor of **PIEDMC-Quaid-e-Azam Industrial Estate Board, Lahore**. The Bidding Document shall not be considered without Bid Security. 
