1. Overview

3. Technical Proposal Format

- iii. Minimum 02 years of work experience with government, semi government and autonomous bodies (attach purchase order/agreement).
- iv. An affidavit on Rs 100/- Stamp Paper which illustrate that currently they are not black listed by PPRA Punjab, and PIEDMC, Quaid-e-Azam Industrial Estate Board, Lahore
- v. Details of all the services & specifications provided by supplier against items detailed as given at Annex 'A'
- vi. Acceptance of technical scope of service and requirement as provided in Annex 'B'
- vii. Signed and Stamped Complete bidding document.
- viii. Bank Draft of the 2% Bid Security must be attached with proposal as per estimated cost mentioned in the Tender notice/Invitation to Bid.

4. Financial Proposal Format

Financial Proposal must include the following in the order given below:

- i. Prices duly entered on the form in the attached BOQ as Annex C.
- ii. Validity period of the quoted price
- iii. Price quoted shall be fixed for one year contract no change in price due to any reason shall not be allowed.

5. Terms & Conditions

5.1 This invitation for bids is open to all national Companies / Group of Companies not below

AA+ rating minimum for Health Insurance service providers in Pakistan.

- 5.2 All prices should be quoted in Pak Rupees and inclusive of all Government Taxes.
- 5.3 A bank draft equal to 2% of the total estimated cost mentioned in Tender notice/Invitation to e-Bid should accompany the Bidding Document as Bid Security drawn in favor of PIEDMC-Quaid-e-Azam Industrial Estate Board, Lahore. The Bidding Document shall not be considered without Bid Security. - 5.4 Bid Security for bidders not selected will be returned a minimum of two weeks after announcement of award and returned to successful bidder after issuance of Purchase order/work order. If the selected bidder fails to accept the work order/purchase order with in stipulated time, Bid Security will be forfeited.
- 5.5 A Bank draft of 10% of the total bid amount as **Performance Guarantee** will be provided by the supplier in favor of **PIEDMC-Quaid-e-Azam Industrial Estate Board, Lahore** after issuance of Letter of Intent, Purchase Order/Work Order which shall remain valid for 12 months beyond delivery period. This performance guarantee will be released after the completion of warranty/guarantee period.
